In consideration of the mutual benefits derived from joint participation of membership in the Lexington Ski and Sports Club, Inc./OVSC, in skiing and all other activities, the undersigned does hereby absolve, release, and waive any and all liability, claims, or demands against the Lexington Ski and Sports Club, Inc./OVSC, its officers, directors, agents, and each and every member thereof, which may arise out of, or be related to, any injury, damages, or pecuniary loss by reason of such membership or activity or participation in said organization, including, but not limited to, all causes arising out of nonfeasance, malfeasance, or negligence of the Lexington Ski and Sports Club, Inc./OVSC, its officers, directors, agents, and each and every member thereof.

Any member or guest of the Lexington Ski and Sports Club, Inc./OVSC, attending an event, or using the property of, or loaning to another his property for use on or in land, water or air at any Lexington Ski and Sports Club, Inc./OVSC event or function does so at the member's or guest's own risk and said member or guest waives any and all claims against the Lexington Ski and Sports Club, Inc./OVSC, its officers, directors, agents, and each and every member thereof, regardless of who uses and/or causes any damages to said property.
